Air Canada announces appointment of Calin Rovinescu as President & Chief Executive Officer; Michael Green appointed to Board of Directors

MONTREAL, March 30 /CNW Telbec/ - David Richardson, Chairman of the Board of Directors of Air Canada, today announced the resignation of Montie Brewer as President and Chief Executive Officer effective April 1, 2009. Calin Rovinescu, a former senior executive with the airline, will succeed Mr. Brewer as President and Chief Executive Officer.

Mr. Brewer added, "I am very proud of the Air Canada team for its accomplishments over the past four years positioning Air Canada as an industry leader in product innovation. It has been an honour to lead this great airline and I am confident Calin is the right person to take the company forward at this time "

Mr. Rovinescu will also assume Mr. Brewer's seat on the corporation's Board of Directors.

Air Canada also announced the addition of Michael Green to the Board of Directors effective immediately. Mr. Green is the lead director of ACE Aviation Holdings Inc.

Mr. Rovinescu concluded "While the challenges in front of us are large, we will continue to build upon the successes of the airline to date and deliver a quality product for our customers, employees and shareholders."
